Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 21 January 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I would like the monthly situation report data on trust virtual ward bed numbers and occupancy rates, compiled by the ICBs to send on to NHSE. Please send me the monthly data for each month from July 2023 onwards.

To be explicit, I am requesting the trust level data. NHS England already publishes the ICB-level data each month, which is in the public domain. I am not requesting the ICB aggregated data, but the data submitted by constituent trusts. Please send this to me in an electronic format by email.


Our Response
