<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 18 March 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Your Request

The "primary care data gathering programme" is a national exercise delivered by Community Health Partnerships on behalf of NHS England. More details can be found <u>here</u>. Its results are published on the Strategic Health Asset Planning an Evaluation (SHAPE) place atlas <u>here</u>.

1: Under the FOI act, can I please ask for the ICS for the full dataset for its system in the primary care data gathering programme in an excel format.

2. If it is not possible to share the full dataset, could I please receive <u>all data (in an excel format)</u> relating to

a) backlog maintenance and

b) size and age of GP premises for the system in the primary data gathering programme.
