<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your Freedom of Information (FOI) request received by the North East and the North Cumbria Integrated Care Board (NENC ICB) on 5th March 2024.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland, and Stockton-on-Tees).

We have dealt with your request in accordance with your "right to know" under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information "held" by a public authority unless an appropriate exemption applies.

Your Request

- 1. Numbers of GPs by region within the NHS North East and North Cumbria Integrated Care Board's jurisdiction who are actively refusing shared care plans (SCPs) for patients diagnosed with ADHD. Please include any available breakdown by specific areas or regions under your authority.
- 2. Similarly, for patients with diagnoses other than ADHD, the number of GPs by region who are who are actively refusing shared care plans (SCPs). Detailed information by area or region would be appreciated.
- 3. If possible, a comprehensive list of GPs within your region, along with their status regarding the acceptance of shared care plans for ADHD and non-ADHD diagnoses.

Our Response

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. In accordance with our duty under s.16 of the
