### <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 22 February 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## Your Request

Some people who are fully CHC funded, and who need a personal use car as part of their package (an assessed need), are being coerced into paying for their own transport.

In some cases, they are being ORDERED to use their PIP mobility allowance to procure a Motability Car for the essential transport element of their Care and Support.

This "top up" payment in kind is off the record, as CHC cannot invoice a patient for ANY component of their fully funded care needs.

PIP mobility is not means tested and cannot be considered when charges for care are applied.

- 1. So, can CHC demand that PIP mobility be used towards fully funded CHC care as a "top up" payment?
- 2. If the answer is yes, what are the circumstances that allow CHC to order the procurement of a Motability Car for a patients Care and Support?
- 3. Or can CHC demand the non means tested PIP mobility be used towards fully funded CHC care in some other way?
