<u>Freedom of Information Act 2000 - Request for Information – NHS North East &</u> <u>North Cumbria Integrated Care Board.</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 09 June 2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (NENC ICB). NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Quality Premium commissioned in both 22/23 and 23/24 – a mixture of different clinical indicators for practices to implement. This is a scheme with 70% automatic funding, 30% based on activity and a QP plus which is payment for specific purposes. This took effect from 01 April within each calendar year and total funding is ± 10.57 per registered patient (70% + 30% elements) plus additional payment for:

Learning Disabilities Health Check £140 per health check undertaken Prostate Cancer £44.13 per injections and £60.73 per annual review NHS Health Checks - £36.55 per health check undertaken plus £15 if meet certain criteria

Contraception per patient – Up to £45.00 for sub-dermal implant insertion and removal £70, fitting of IUD £90, 3-6 week check of IUD £20 and removal of IUD £20

Smoking cessation - £15.50 to set quit date, £41 for each user that has quit for 4 weeks and £41 for those who have quit at 12 weeks.

Shared Care – commissioned in both 22/23 and 23/24 – for monitoring, review and interventions in respect of a wide list of drugs and also includes treatment room services

Paid at £3.14 per patient per annum
