<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 24 September 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing with a Freedom of Information request regarding the pricing and volume of both inhouse and outsourced service-line agreements in ophthalmology. Please provide the following information for your organisation for the past five financial years (FY2019-20 to FY2023-24):


1. Total Spend and Volumes

The <u>total</u> spend (in £) and volume (number of procedures) for both in-house and outsourced provisions for each of the following ophthalmology procedure groups:

- Cataract surgeries
- AMD eye injections
- AMD photodynamic therapy
 - o LASIK
 - o SMILE
- Corrective laser eye surgeries (e.g. PRK, LASEK, TransPRK)

If your records use different categorisations or sub-categories within these procedure groups, please provide the total spend and volumes for those as well.





2. Outsourcing Spend and Volumes by provider

The volume and spend for each ophthalmology procedure group <u>outsourced</u>, broken down by specific private providers. Please specify the volume and spend for each of the following procedure groups for each provider:

- Cataract surgeries
- AMD eye injections
- AMD photodynamic therapy
 - o LASIK
 - o SMILE
- Corrective laser eye surgeries (e.g. PRK, LASEK, TransPRK)

If a detailed breakdown is not available, please provide a list of the ophthalmology groups/providers to which your organisation outsources.

To clarify: If the service is outsourced to anyone (an NHS trust, private provider, IS provider, etc) then it would count as 'outsourced' – so please break down how much of each procedure (volume) is done by each provider and how much is spent on each (data availability allowing).

If you expect the request to exceed time and cost limits, please prioritise spend over volume.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. However, we have determined that the information is held by the acute hospital NHS foundation trusts (FTs) within the North East and North Cumbria region.
