<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 5 September 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

- 4. When do your contracts expire?
- 5. Do you have any planned upgrades of the software? If so, when?
- 6. Are you planning to go to market for a different HR or Finance system? If so, when?
- 7. Who is the person responsible for your HR or Finance system? Please provide: Full name, job title and contact information, if possible.

- 1. All ICBs are mandated to use the Integrated Single Financial Environment (ISFE), currently provided by NHS Shared Business Services.
- The HR service is a service purchased through North of England Commissioning Support Unit. Management of HR related matters is conducted through the Employee Service Record (ESR) developed by the NHS Business Services Authority. The payroll function is a purchased service through Northumbria Healthcare Foundation Trust and payroll processing is conducted through ESR.
- 3. The ICB does not hold the contract for the ISFE and has no information on annual contract values. This would need to be requested from NHS England. In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, the FOI address for NHSE is <u>england.contactus@nhs.net</u> Please write "Freedom of Information" in the subject line. HR and payroll services are provided as part of a wider contract which is not broken down by individual service.

- 6. For finance, please refer to the response to question 1. The ICB is not planning to go to market for a different HR system.
