Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 23 September 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Under the Freedom of Information Act, I would like to request the following information. Please provide:

1. The sum spent by the ICB/paid by the ICB to organisations in the voluntary, community and social enterprise sector (VCSE), including charities, a) In 2022-23 (either April 2022-March 2023; or July 2022 (when ICBs were created)-March 2023 – whichever is held by your organisation – please specify, and b) in 2023-24.
2. The sum the ICB plans to spend on organisations in the voluntary, community and social enterprise sector (VCSE), including charities, in 2024-25.
3. The sum paid in grants by the ICB/paid by the ICB to organisations in the voluntary, community and social enterprise sector (VCSE), including charities, a) in 2022-23 (either April 2022-March 2023; or July 2022 (when ICBs were created)-March 2023 – whichever is held by your organisation– please specify, and b) in 2023-24.

4. The sum the ICB plans to pay in grants to organisations in the voluntary, community and social enterprise sector (VCSE), including charities, in 2024-25.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

1. In 2022/23 (9 months, July 2022 to March 2023), the sum spent by the ICB/paid by the ICB was £34.428m. In 2023/24, this sum was £46.692m.
2. The sum (opening baseline) the ICB plans to spend on organisations in the voluntary, community and social enterprise sector (VCSE), including charities, in 2024/25 is £38.864m.
3. The ICB's contract register has identified the following spend which potentially falls into the categories requested. The spend relates to the grant agreement values in the financial year, but all funding may not have been transacted in that financial year:

2022/23: £6,769,303

2023/24: £8,058,750
