**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 6 August 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

We have dealt with your request in accordance with your “right to know” under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information “held” by a public authority unless an appropriate exemption applies.

**Your Request**

Could I please request information regarding all primary care rebates that are currently active in Cumbria and Northeast ICB.

If this could detail the branded name of each product along with the start and contracted finish time for each existing rebate agreement on branded medicines from pharmaceutical companies and how long they last. I fully understand that the financial details of the rebates would be considered commercially confidential.

**Our Response**

We responded to this original request on 8 August 2024 advising you that NENC ICB does not hold any of the information requested and redirecting you to the North East and Yorkshire Regional Contracting Team.

Subsequent to your FOI request to the North East and Yorkshire Regional Contracting Team and their redirect back to us, they forwarded the information you requested to NENC ICB. This is summarised in the table below.
