<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received on 3 June 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

Under the Freedom of Information Act 2000 I would like to request the following information from your organisation:

How much was spent on translation and interpretation costs over the last five financial years (2020/21, 2021/22, 2022/23, 2023/24, 2024/25)?

Please could this data be broken down into a total sum over the five years and also broken down by each financial year.

Please can a separate list of the top five languages incurring the highest cost in the financial year 2024/25 also be included, with how much was spent on each language.

Our Response

In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB holds some of the information requested. Interpretation was transferred from NHS England to the ICB in July 2023, so we can provide information from this date. The total amounts are in the table below, invoices received by NENC ICB do not include a breakdown of languages.
