# <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 8 September 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## Your Request

I am writing to make a request under the Freedom of Information Act 2000. Specifically, I would like to request information regarding your Assisted Discharge and Support at Home Services.

For clarity, we are referring to those services where a third-party provider offer support, transport and settling services to patients to ensure an efficient, safe discharge which reduces the incidence of delayed or failed discharges. Support at Home services are those where a third party provides a set period of support to patients recently discharged from hospital to increase independence and reduce the incidence of readmission.

- 2. What is the annual value of the contract?
- 3. What is the duration of the contract?
- 4. What are the start and end dates of the contract (plus any potential extension periods)?

- 1. Cumbria Community Foundation and Cumbria CVS grant agreements, distributed to various third sector organisations to assist with discharge.
- 2. The total contract value is £838k.
- 3. Contract duration is 12 months.
- 4. Contract runs from April 2023 to March 2024.
- 5. The response is not applicable.

North Tyneside does not commission specific Assisted Discharge and Support at Home services.

## Northumberland place

- 1. Northumberland Local Authority and NHS Northumbria Healthcare FT provide these services.
- 2. Annual contract values are: Acute short term support team, £1.3 million, Local Authority short term support team, £3 million
- 3. Contract duration is 12 months.
- 4. Contract runs from 1 April to 31 March 2024.
- 5. Performance measurement is part of routine contract management and monitoring arrangements with acute and local authority providers

# South Tyneside place

1. Age Concern Tyneside South (Hospital to Home Service)

- 2. Annual contract value is £138,660.
- 3. Duration of the contract is 12 months.
- 4. Contract runs from 1 April 2023 to 31 March 2024.
- 5. Key Performance Indictors/Reporting Outcomes:
  - Three-month and six-month follow-up reviews to conducted to determine if readmission or further fall has been avoided.
  - A successful outcome is that the person no longer requires our support, they can manage independently therefore the service can end.
  - It is expected that a diverse range of signposting to other services and agencies will take place, reflecting diversity of service users and holistic approach.
  - Improvement reflected in scoring of SWEMWBS & Rockwood Frailty tools used at start and end of interventions.
  - Case studies to personalise interventions and reflect the difference it makes in day-to-day life.
  - Make contact within 24 hours to people of all ages discharged on pathway 0, to establish wellbeing and offer support.
