<u>Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board.</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 7 July 2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (NENC ICB). NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up — Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

- Gynaecology
- Orthopaedics including spinal
- Direct access form the ESP at connect physiotherapy services
- Ophthalmology (cataracts and Yag laser)
- Urology including urodynamics
- Pain management
- Direct access to diagnostics (ultrasound)
