<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 31 July 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

We have dealt with your request in accordance with your "right to know" under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information "held" by a public authority unless an appropriate exemption applies.

Your Request

Under the Freedom of Information Act 2000, I would like to request the below information please:

- 1. How much money have GP practices within the ICS spent on EHR (Electronic Health Record software) over the last 12 months? If this information is available per practice (e.g. in a spreadsheet) please that would be great, if not a total sum of all GP practices in the ICS is fine.
- 2. More broadly, how much money have GP practices within the ICS spent on any type of software in the last 12 months? As per question 1, if this information is available per GP practice, please that would be great, and if not a total sum of all GP practices in the ICS is fine.
- 3. How many full-time employees (FTE) does the ICB directly employ who have a Digital, Data or Technology (DDaT) role?

I understand that under the Freedom of Information Act, I am entitled to a response within 20 working days of your receipt of this request. If my request is too broad or unclear, I would be grateful if you could contact me so that I can refine my request.

Our Response
