Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received on 17 July 2026 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Your Request

I am writing to make a formal request for information under the Freedom of Information Act 2000.

Please could you provide the current, up to date (2026) names and direct contact information (email addresses and telephone numbers) for the following roles within each Primary Care Network (PCN) operating under the NHS North East and North Cumbria Integrated Care Board:

1. Clinical Directors
2. Network Managers

Please can you provide this 2026 information in an electronic format, such as an Excel spreadsheet or a CSV file, categorized by the name of each PCN.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

The attached spreadsheet shows names, email addresses and telephone numbers of PCNs, where held by the ICB. We have indicated where the ICB does not hold information.

Also supplied is a list of PCNs and their associated GP practices. Telephone numbers are for the practices, rather than the individual PCN. We do not hold a list of telephone numbers for individual PCNs.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website <https://northeastnorthcumbria.nhs.uk/>.
