## <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 29 January 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## Your Request

Please release the following information under the terms of the Freedom of Information Act. How much funding was given to hospices in the North East of England in each of the following years: 2019, 2020, 2021, 2022, 2023 and 2024.

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

The table below shows funding paid by the North-East & North Cumbria ICB (the ICB) and predecessor Clinical Commissioning Groups (CCGs) to hospices. The ICB was established on 1 July 2022, funding information prior to that date relates to the eight predecessor CCGs across the North-East and North Cumbria region.

The information is shown by financial year (of when payment was made) and covers the North-East and North Cumbria region to be in line with the ICB footprint.

It shows only direct payments made to Hospices by the ICB and doesn't include any funding paid via other contracts with Local Authorities or NHS Foundation Trusts for example. This includes all payments made to Hospices which isn't necessarily all for Hospice provision.

Figures shown for 2024/25 are as at the end of January 2025, with the financial year for the ICB ending on 31<sup>st</sup> March 2025.
