**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 4 June 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

I am writing to you under the Freedom of Information Act 2000 to request the following information from your Trust. Please may you provide me with an answer to the following:

I am enquiring about ophthalmology – specifically tariffs related to the treatment of patients with Wet age-related macular degeneration. When diagnosed, patients require treatment involving regular injections into the eye and repeated OCT scans. The questions I have are as follows:

For patients being treated by providers for wet-AMD, what tariffs do you apply?

I am interested to know:

- Do you use national tariffs for outpatient appointments, scans, and for treatments. If so, which ones do you use? Please provide HRG codes where possible.
- If locally negotiated tariffs are used, please provide details of these. If 'bundled' (e.g. include treatments/scans etc), please advise on what is included in the cost. If 'unbundled' (e.g. each element is costed separately), please advise on the locally agreed price for each element

## Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.
