Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received on 12 September 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

We wish to make a freedom of information request regarding any recent of current applications for inclusion in the pharmaceutical list. The area we wish to enquire about is Carlisle CA1 area.

1. Can you please advise if any new pharmacy applications have been received or granted in the 24 months to September 2025?
2. If have any applications been granted, please can you provide us with a copy of the approval.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

1. There has been 1 application received for inclusion in the pharmaceutical list for CA1 in the 24 months to September 2025. This is Olivemead Ltd – Current needs application. Estimate address – Petteril Bank Road Shops, Carlisle, CA1 3AH.
2. The application was granted by NHS Resolution on 15 January 2025, reference: 26340. The copy of approval is publicly available on the NHS Resolution website at [PCA Decisions Archive – NHS Resolution](#). In accordance with s.21 of the FOIA, we are not required to provide information in response to a request if it is reasonably accessible to you by other means.
