<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 6 September 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Under the Freedom of Information Act I would like to request the following information:

- Does the Integrated Care Board have established referral pathways for patients to access employment support programmes?
- Please provide a list of all current employment support programmes that the Integrated Care Board is involved with (A) commissioning or delivering (B) referring patients to.
- How many patients have been referred to employment support programmes for each of the last five years?
- Has the ICB entered into any agreements or partnerships with the Department for Work and Pensions concerning patients who are out of work? If so, please provide copies or details.
- Has the ICB prepared a written strategy or policy document that sets out how you work with partners, including the Department for Work and Pensions, to support patients out of work due to ill-health or disability to return to work? If so, please provide this.
