# <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 13 March 2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

# Request

- 1) The number of overnight and weekend shifts in 2022 at any of your out of hours providers in which no GP was on duty.
- 2) The number of patients covered by the out of hours provider where there was no GP on duty for at least one shift in 2022.
- 3) What advice was provided to patients during shifts where no GP was on duty in 2022?
- 4) The number of overnight and weekend shifts in 2022 at any of your out of hours providers in which just one GP was on duty.
- 5) The number of patients covered by the out of hours providers where there was just one GP on duty for at least one shift in 2022.
