<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 13 March 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I would like to request information regarding the services your Integrated Care System (ICS) provides for the diagnosis and treatment of polycystic ovary syndrome (PCOS). Please provide responses to the following:

- 1. PCOS Diagnosis and Treatment Services
 - a. What services does your ICS currently provide for the diagnosis and treatment of PCOS?
 - b. Are these services delivered through primary care, secondary care, or specialist clinics?
- 2. Diagnostic Pathway
 - a. What is the diagnostic pathway for PCOS within your ICS?
 - b. Are there specific tests, assessments, or criteria mandated for a PCOS diagnosis?
- 3. Training and Guidance for Healthcare Professionals
 - a. What training or guidance is provided to healthcare professionals within your ICS regarding the diagnosis and management of PCOS?
 - b. How are healthcare professionals trained to understand the long-term implications of PCOS, such as its association with infertility, diabetes, and cardiovascular disease?

 - a. Has your ICS conducted any assessments or received feedback about barriers to accessing PCOS services?
 - b. What steps have been taken to address any identified barriers?
 - c. Has your ICS identified any disparities in PCOS diagnosis, treatment, or care outcomes for specific ethnic or socio-economic groups?
- 9. Multi-Disciplinary Team (MDT) Involvement
 - a. Are multi-disciplinary teams (MDTs) involved in PCOS care within your ICS?
 - b. Which healthcare professionals typically form part of these teams?
 - c. How are MDTs coordinated to ensure holistic and patient-centred care for PCOS patients?
- 10. Public Awareness and Patient Information
 - a. Does your ICS engage in public awareness campaigns or community education regarding PCOS?
 - b. Are there any ongoing initiatives to improve understanding of PCOS among patients and the general public?
 - c. Does your ICS provide specific information on PCOS for both healthcare professionals and patients?

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

North East ICB places (County Durham, Newcastle Gateshead, Northumberland and North Tyneside, Sunderland and South Tyneside and Tees Valley

1. On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.

However, we have determined that the information is held by the acute hospital NHS foundation trusts (FTs) and individual GP surgeries within the North East region.

North Cumbria ICB place

- 1. Routine diagnosis is made in Primary Care taking into account history and symptoms. Further diagnostic tests may be required which would be arranged via GPwSI services or secondary care. Further specialist care would be via the local acute trust (gynaecology / endocrinology / dermatology). On-going treatment would be provided by Primary Care.
- Routine diagnosis takes place in primary care based on local guidelines (Heath pathways) and NICE Clinical Knowledge Summaries (CKS) – <u>Polycystic Ovary Syndrome</u> Ultrasound may be required for confirmation of diagnosis.
- 3. NENC ICB follows NICE and Healthpathways guidance.

- 5. This information is not held in North Cumbria ICB place.
- 6. North Cumbria Women's hub does not currently offer services specifically for PCOS. If a patient presented with symptoms, they would be referred to their GP Practice for diagnosis
