Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 17 June 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing to you to make a Freedom of Information request regarding the commissioning processes within the North East and North Cumbria ICB where public and private healthcare are mixed.

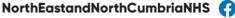
Various local NHS ICBs have published their own guidance on the boundaries between NHS and private healthcare [2,3,4,5,6], a set of similar publications with dates ranging between 2009 and 2023 which I understand are based on the same NHS Commissioning Board Interim Commissioning Policy: NHSCB/CP/12.

From my understanding of these policies, the mixing of public and private healthcare is permitted, provided this is not within the same "episode of care"- a commonly used phrase within these policies. An episode of care is defined in [2] as:

"A period of engagement between an NHS commissioned healthcare intervention and the patient in which NHS commissioned care is provided to the patient. The following are examples of episodes of care:

- A single visit to the GP
- An outpatient appointment
- A series of diagnostic tests relating to the same person at an NHS hospital on the same day
- A day case operation with all the supporting clinical activity before and after the operation on that day
- The initial assessment and prescription of a cancer drug. If the drug is required to be given at a series of outpatient appointments, then each attendance will be a separate episode of care."

I have been unable to source a copy of a policy implementing NHSCB/CP/12 for the North East and North Cumbria ICB, my local integrated care board.

In responding to this Freedom of Information request, please could you:

- 1. Provide me with a copy of your local ICB policy implementation on the mixing of public and private care if this exists, preferably via email.
- 2. Please confirm whether the above definition of "episode of care" is also adopted within the North East and North Cumbria ICB region.
- 3. Alternately, if a different approach is adopted at the local level, please can you explain how patient choice and the mixing of public and private healthcare is implemented, with reference to relevant national policy (including [1]) if necessary.

I look forward to hearing from you. I would be most grateful if you could acknowledge receipt of this email and indicate how long you would expect to require to service this request. If you require any further information, please do not hesitate to contact me.

- 3. NENC ICB does not do anything different to national policy.
