Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received on 11 December 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

I'd like to request the following records under the Freedom of Information Act. By way of context, the requested records detailed below relate to the list of 16 national medicines optimisation opportunities published by NHS England each financial year since the summer of 2023. 1. A list of the national priorities you have been pursuing in 2025-26.
2. A list of any local priorities you have been working on in 2025-26, as distinct from those in point 1 above.
3. A list of any national priorities you will be pursuing in 2026-27.
4. A list of any local priorities you will be pursuing in 2026-27, as distinct from those in point 3 above.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

Please find our response below. Unless otherwise stated, all information relates to NENC ICB and includes activities inherited from predecessor Clinical Commissioning Groups where relevant.

1. In 2025-26, NENC ICB has been pursuing the national medicines optimisation opportunities published by NHS England, which set out system-wide priorities to improve quality, safety, value and sustainability of prescribing.

Delivery in NENC ICB has included:

- Respiratory optimisation, including reduction of short-acting beta-agonist (SABA) inhaler overuse and optimisation of COPD inhaler therapy (including triple therapy inhalers)
- Antimicrobial stewardship, including reduction in total antibacterial prescribing volume
- Optimisation of high-risk medicines, including opioids and gabapentinoids
- Reduction of high-dose proton pump inhibitor (PPI) prescribing
- Best-value use of direct oral anticoagulants (DOACs), in line with NHS England commissioning recommendations
- Reduction of low-value or ineffective prescribing (e.g. bath and shower emollients, inappropriate vitamin D prescribing, lidocaine patches outside licensed indications)
- Medicines safety and overprescribing reduction, including work on oversupply
- Increased use of generics and biosimilars where clinically appropriate

These activities align with the NHS England national medicines optimisation opportunities, which are publicly available and accessible. NHS England guidance:

2. In addition to national priorities, NENC ICB has pursued a range of locally agreed medicines optimisation priorities in 2025–26, reflecting local prescribing patterns, cost pressures, and patient safety considerations.

Local priorities include:

- Formulary-led switching programmes (e.g. mesalazine preparations, riluzole formulations)
- Review and reduction of prescribing for medicines with local safety or cost concerns (e.g. dicycloverine, gluten-free foods)
- Optimisation of oral nutritional supplement (ONS) prescribing following the introduction of new regional guidance
- Review of high-cost liquid formulations (e.g. omeprazole suspension)
- Optimisation of medical devices and consumables (e.g. safety needles and safety lancets)
- Identification and action on locally identified generic prescribing opportunities
- Implementation and use of digital prescribing support tools (e.g. OptimiseRx and AnalyseRx)

Local priorities are developed and delivered through established governance routes, including the ICB medicines optimisation function, formulary processes, and regional advisory groups.

3. At the time of this response, NHS England has not yet published the national medicines optimisation opportunities for the 2026-27 financial year.

As such, NENC ICB is unable to confirm a definitive list of national priorities for 2026-27. Once published, NENC ICB will consider and implement these priorities in line with national guidance.

4. Local medicines optimisation priorities for 2026-27 are not yet finalised. Future local priorities will be informed by:

- NHS England national priorities once published
- The NENC ICB Medicines Strategy 2025-2030
- Prescribing data, safety intelligence, and financial considerations
- Engagement with system partners and clinical stakeholders
