Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your Freedom of Information (FOI) request received by the North East and the North Cumbria Integrated Care Board (NENC ICB) on 18 March 2024

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland, and Stockton-on-Tees).

We have dealt with your request in accordance with your “right to know” under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information “held” by a public authority unless an appropriate exemption applies.

Your Request

Could I please make an FOI request for the ICB to provide their 2024/2025 list of capital schemes as detailed within the Joint Capital Resource Use Plan 2024/2025, covering the following items:

- Region
- ICB / System
- Introduction
- Assumed Sources of Funding for 2024 / 2025
- Overview of Ongoing Scheme Progression
- Risks and Contingencies
- Business Cases in 2024 / 2025
- Cross System Working
- Capital Planning & Prioritisation
- Capital Plan

Could you also provide the completed System CDEL for the joint capital resource use plan 2024 / 2025.

I look forward to receiving a response within the statutory 20 working days.

Our Response
