<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 30 August 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

Adult Autism Assessments and Adult ADHD Assessments and Treatment

Adult Autism assessments and adult ADHD assessments and treatment are answered both in the same response below. NENC ICB commission the following providers on a block basis for ADHD services and Autism assessment and treatment services:

- Cumbria, Northumberland, Tyne & Wear NHS Foundation Trust (FT) expiry date of contract is 31st March 2027 with an option to extend the contract term twice, up to a maximum of two years.
- Tees, Esk and Wear Valleys NHS FT expiry date of contract is 31st March 2027 with an
 option to extend the contract term twice, up to a maximum of two years.
- Psychiatry UK (North Cumbria, non-NHS) expiry date of contract is 31st March 2025 no option to extend.

Please note information can only be provided for this FOI based on patients accessing locally commissioned services. Patients are also able to access services provided by providers outside of locally commissioned services under the NHS Right to Choose, but the NENC ICB would not hold this information.

Children and Young People's (CYP) Autism Assessments and CYP ADHD Assessment and Treatment

Children and young people (CYP) Autism assessments and CYP ADHD assessments and treatment are answered both in the same response below:

- Cumbria, Northumberland, Tyne & Wear NHS FT expiry date of contract is 31st March 2027 with an option to extend the contract term twice, up to a maximum of two years.
- Tees, Esk and Wear Valleys NHS FT expiry date of contract is 31st March 2027 with an
 option to extend the contract term twice, up to a maximum of two years.

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the requested information for contract particulars. However, on this occasion, it is not possible to satisfy all elements of your request.

The Freedom of Information Act (FOIA) 2000 contains a number of exemptions that allow a public authority to withhold certain information from release. Some of the requested information is exempt under s.43(2) of the FOIA2000 as disclosure is likely to prejudice the commercial interests of a person as defined by the Act. The s.43(2) exemption applies to all point 7 in all questions.

S.43(2) of the Freedom of Information Act protects against the disclosure of information where it would be likely to prejudice the commercial interests of either a third party or the public authority itself. We are of the opinion the release of the specific details would, or would be likely to, prejudice the commercial interests of the public authority, NENC ICB.

The Information Commissioners Office has established a multi criteria test for assessing whether a section 43(2) exemption is applicable to the requested information. The first criteria is to determine if the information relates to or could impact on a commercial activity, the second criteria is if the commercial activity is conducted in a competitive environment, and finally if that information is commercially sensitive.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website https://northeastnorthcumbria.nhs.uk/.

If you are unhappy with the service you have received in relation to your request and wish to request a review of our decision, you should write to the Senior Governance Manager using the contact details at the top of this letter quoting the appropriate reference number.

If you are not content with the outcome your review, you do have the right of complaint to the Information Commissioner as established by section 50 of the Freedom of Information Act 2000. Generally, the Information Commissioner cannot make a decision unless you have exhausted the complaints procedure provided by the North of England Commissioning Support Unit.
