## <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received on 8 April 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

## **Your Request**

Under the Freedom of Information Act 2000, I would like to request information regarding the NHS Lung Cancer Screening (LCS) programme (previously known as the Targeted Lung Health Check) within your ICB region:

- 1. Which areas currently have an active LCS/TLHC programme?
- 2. For each active programme:
  - Is it delivered in-house or by an external provider?
  - If external, who is the provider?
  - When is the next planned re-procurement or retender?
- 3. Which areas currently do **not** have an active programme?
  - For those areas, is a programme planned? If so, when?

- 1. All areas in the North East and North Cumbria (NENC) ICB have an active LCS/TLHC Programme.
- 2. There are 4 projects in operation.
  - None are delivered in-house by the NENC ICB.
  - The external providers are:
    - Newcastle and Gateshead The Newcastle upon Tyne Hospitals NHS Foundation Trust (FT).
    - North programme County Durham and Darlington NHS FT, Northumbria Healthcare NHS FT and North Cumbria Integrated Care NHS FT.
    - South Tyneside and Sunderland South Tyneside and Sunderland NHS FT.
    - Tees Valley InHealth, South Tees Hospitals NHS FT. North Tees and Hartlepool NHS FT and County Durham and Darlington NHS FT.
  - There are no plans for procurement.
