Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 26 February 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am submitting a request under the Freedom of Information Act 2000 regarding the Mental Health Support Teams (MHSTs) operating in Newcastle and Gateshead. I would be grateful if you could provide the following:

1. *Performance Metrics* – Data on MHSTs in Newcastle and Gateshead over the past two years, including:
 - Number of schools and colleges covered.
 - Number of children and young people supported.
 - Types of interventions delivered.
 - Measured outcomes or effectiveness of interventions.
2. *Evaluation Reports* – Any internal or external assessments, audits, or reports on MHST performance, service effectiveness, or impact in these areas.
3. *Funding and Resource Allocation* – Information on funding provided for MHSTs in Newcastle and Gateshead, including:

- Breakdown of funding allocation.
- Any specified targets or expectations linked to this funding.

I do not require any commercially sensitive details related to financial negotiations, contracts, or proprietary data. However, if certain elements of my request fall under exemptions, I would appreciate a partial disclosure of any non-exempt information.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

1. Performance metrics:

- *Number of schools and colleges covered.*
Newcastle – 57
Gateshead – 67
- *Number of children and young people supported.*
Gateshead targeted interventions – 714
Gateshead universal interventions – 16,971
Newcastle targeted interventions – 443
Newcastle universal interventions – 20,507
- *Types of interventions delivered.*
Initial assessment, 1:1 sessions, check-in, parent/carers contact, parent/carers info sharing, parent/carers CBT session, professional contact, discharge resources, small group, class, assembly, parent/carers workshops, professional workshops, professional meetings, drop-in
- *Measured outcomes or effectiveness of interventions.*
Of the 172 young people who completed Goal Based Outcome forms, the following results were captured:

Increase – 162
Decrease – 6
No change – 4

Gateshead – £605,978
