## <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 3 September 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## Your Request

I am seeking information under the Freedom of Information Act, please can you provide the following:

- 1. Between April 6 April 5, 2023/24, what was the ICB's total spend on Children's Mental Health?
  - a. Can you also provide this as a percentage of the overall ICB budget? Or simply, the figure for the overall budget of each ICB?
- 2. Between April 6 April 5, 2023/24, what is the total number of children (under18) referred to CYPMHS/ CAMHS?
  - a. Can you also provide this as a percentage of the U18 population and/or the figure of the U18 population within the ICB.
  - b. What is the total number of children on the waiting list for mental health treatment within the ICB?
  - c. What is the average waiting time for children's mental health treatment with the ICB?

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

- 1. NENC ICB records expenditure recorded in financial years, so this response covers the period 1 April 2023 to 31 March 2024. The spend on children and young people's (CYP) mental health services during this period was £64 million. This spend excludes:
  - Services for children and young people with learning disabilities and/or autism, and ADHD support or services, except where there is co-occurring primary mental health need.
  - Services funded from specific service development funds (SDF)
  - Specific drugs prescribed by GPs for the treatment of CYP mental health as we are unable to obtain that information.

This spend (with the exclusions noted above) equates to around 1% of the ICB's total budget for 2023/24.

2. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. However, we have determined that the information is held by South Tyneside and Sunderland NHS Foundation Trust (FT), Northumbria Healthcare NHS FT Cumbria, Northumberland, Tyne and Wear NHS FT and Tees, Esk and Wear Valley NHS FT.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email addresses for those hospitals to make your request.
