**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 17 July 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

We have dealt with your request in accordance with your “right to know” under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information “held” by a public authority unless an appropriate exemption applies.

**Your Request**

I would like to make a request under the Freedom of Information Act, please.

I'd be very grateful if you could provide me with the following information regarding all GP practices; eating disorder in-patient and out-patient treatment centres; hospitals and pharmacies in your PCNs:

1. Name of organisation
2. Type of organisation (GP practice; eating disorder in-patient and out-patient treatment centre; hospital or pharmacy)
3. Address of organisation
4. Practice Manager's name

5. Practice Manager's email address (or main email if not available)
6. Practice Manager's telephone number (or main number if not available)

## **Our Response**

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.

However, we have determined that the information is held by Primary Care Networks (PCNs) within the North East and North Cumbria region.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided a link to the NHS Digital website, which holds lists of GP practices and practices within each PCN, by ICB region.
