Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 23 April 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing to you under the Freedom of Information Act (2000) to request information relating to the provision of ADHD (attention deficit hyperactivity disorder) services by NHS North East and North Cumbria ICB.

1. Please name the organisation(s) that deliver(s) CYP (children and young people) ADHD assessment / diagnoses in your ICB area.
2. Please name the organisation(s) that deliver(s) Adult ADHD assessment / diagnoses in your ICB area.
3. When did the contract(s) begin and when is the contract(s) due to end.
4. What is the annual spend for this service for 2024, and for the last 5 years?
5. How is the service contracted – is it Block, Activity-based, or AQP contracting?
6. If the service is commissioned with other CCGs, ICSs or Trusts, which are these?
7. At what prevalence (% of the population) have the contracts been commissioned against?
8. Please outline the ADHD pathways in your area, including key referral sources.
9. How many children and young people are currently waiting for a CYP ADHD assessment in your area? What is the longest and median wait time from a referral?

10. How many Adults are currently waiting for a ADHD assessment in your area? What is the longest and median wait time from a referral?
11. Within the last year, how many children and young people were assessed for ADHD within 12 weeks of referral?
12. Within the last year, how many Adults were assessed for ADHD within 12 weeks of referral?
13. Within the last year, how many children and young people were discharged without assessment?
14. Within the last year, how many Adults were discharged without assessment?
15. For the last 5 years, please give the number of patients per year (both adult and CYP respectively) in the ICB who were:
 - a. Referred for ADHD assessment.
 - b. Given an ADHD assessment.
 - c. Given an ADHD assessment from a 'Right to Choose' provider, outside the service contracted.
 - d. Diagnosed with ADHD.
16. For the last 5 years, what was the average number of ADHD-qualified staff delivering services in the area?
 - a. How does this split by role:
 - i. Qualified psychiatrists
 - ii. Paediatricians
 - iii. Speech and Language therapists
 - iv. Clinical Psychologists
 - v. For i-iv, please also give numbers of trainees.

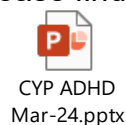

Pathways before the transfer will be as CNTW. Once patients receive a diagnosis, they are either discharged by Psych-UK or referred back to CNTW to continue on their pathways.

 - d. 2310 adults have been diagnosed with ADHD.
