**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 9 July 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

Can you let me know if you commission packages with Mowbray House, High Hope Street, Crook, County Durham, DL15 9JG.

1. Did you apply an uplift in fees for both 2023-24 and 2024-25?
2. If an uplift was applied what percentage uplift was applied for each respective year?

**Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

No clients in Mowbray House for ICB areas Newcastle Gateshead, North Cumbria, North Tyneside and Northumberland and Sunderland and South Tyneside.

For County Durham, in 2023/24 rates were applied in line with a letter received from the provider and no uplift has yet been agreed for 2024/25.

For Tees Valley ICB area, the uplift was 6% in 2023/24 and has not yet been agreed for 2024/25.
