Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 13 January 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am reaching out to request information regarding your ICB's strategies and processes related to well-being and mental fitness, as well as opportunities for supplier engagement. I would appreciate your assistance in providing the following information:

1. Local Well-being and Mental Fitness Strategy

- a. Documents, reports, or any public information outlining your ICB's strategies for supporting the mental health and well-being of NHS staff, particularly in leadership roles.
- b. Details about any programs or initiatives aimed at enhancing mental fitness and resilience within the workforce.

2. Supplier Engagement Process

- a. Information on how to apply to become an approved supplier for services related to wellbeing, mental fitness, leadership development, or coaching.
- b. The process and criteria for being considered for inclusion on your ICB's supplier list for these types of services.

- a. The contact details of the individuals or teams responsible for well-being, mental fitness, or leadership development programs within your ICB.
- b. Any procurement or partnership-related contacts who can provide further guidance on opportunities for collaboration.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

- 1. NENC ICB does not have a specific strategy relating to local wellbeing and mental fitness.
- 2. All of the ICB contracting opportunities, where relevant, are advertised via Atamis and the Government Platforms Contracts Finder and Find a Tender Service, following the relevant Procurement Legislation process.

Where relevant authorities are required to offer choice to patients under the National Health Service Commissioning Board and Clinical Commissioning Groups (Responsibilities and Standing Rules) Regulations 2012 (as amended) providers can apply to provide these services via Atamis. For example, follow the steps below to locate the NENC ICB Patient Choice Accreditation Questionnaire:

- b. Locate the opportunity in 'Find Opportunities' (Patient Choice Accreditation North East and North Cumbria ICB (Project Reference Number C228245))

- d. From your Home page select 'Click Here' under 'My Proposals and Quotes'.
- e. The questionnaire is located within the 'Requirements Section', please click into each of the links which are titled:
 - i. Initial Compliance Questionnaire to Patient Choice
 - ii. Sections 1-5: Selection Questionnaire, Parts 1, 2 and 3
- f. Once all questions are completed, please click on 'Submit'.
