<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 24 April 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

Minutes of meetings and emails from the period 1st June 2021 to now held within your organisation in relation to the medication Inclisian.

Our Response

NENC ICB does hold some of this information. It will not be possible to access all emails sent across the ICB in relation to Inclisiran as the ICB estimates that the cost of complying with your request would exceed the appropriate limit.

The ICB estimates that a manual exercise to retrieve this information would exceed the appropriate limit set out in section 12(1) (cost limit) of the Freedom of Information Act 2000. Currently this is set at £450 for the ICB, which equates to 18 hours or more of an officer's time.

It is difficult to accurately estimate the amount of time it will take. Each individual place (former CCG) within the ICB would need to carry out this exercise. Our best estimation is that for the whole ICB this exercise would take in excess of 146 hours as outlined below.

NENC ICB consists of 14 places (3.3 +0.75)*14 = 56.7 hours for place minutes 1 hour for corporate minutes 85 hours for emails 4 hours to deliver the above

= 146.7 hours (but spread out across hundreds of people)

The reason for the amount of time is that emails sent and received from a number of different email addresses will need to be searched as well as all bulletins, news alerts, websites, meeting minutes and informal notes from meetings.

Under the Section 16 duty to provide advice and assistance, the CCG may be able to comply with a refined request. For example, if the request were to be limited to formal documentation at meetings, inclusion in work plans or training events this would be more manageable within the FOI timescale requirements. Supplying minutes of formal meetings and publications on websites would considerably reduce the time required and allow us to respond within the appropriate limit.

We feel that medicines committee meeting minutes is something we can provide in those cases where they are not already publicly available.

In line with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website https://northeastnorthcumbria.nhs.uk/.

If you are unhappy with the service you have received in relation to your request and wish to make a complaint or request a review of our decision, you should write to the Senior Governance Manager using the contact details at the top of this letter quoting the appropriate reference number.

If you are not content with the outcome your complaint, you may apply directly to the Information Commissioner for a decision. Generally, the Information Commissioner cannot make a decision unless you have exhausted the complaints procedure provided by the North of England Commissioning Support Unit.
