## Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 10 September 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## **Your Request**

For each year from 2021-2023 inclusive, (calendar or financial depending on the data is collected), please provide the total budget for maternity services per integrated care system, broken down by antenatal care, labour and birth, and post-natal care [as classified by the NHS as 6-8 weeks].

Please break the figures out by year and by sub-type (ie. antenatal care, labour and birth, and post-natal care).
