<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 16 August 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I would like to submit a Freedom of Information request to access the following data:

- Whether your ICS has a Local Enhanced Service (LES) **currently** in place for Inclisiran (brand name: Leqvio). This is a cholesterol lowering drug. (YES/NO)
- If YES, I would like to request the **start and end dates** of the LES, and **the terms** of the contract.
- Has a LES for Inclisiran ever been in place within your ICS?

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

NENC ICB has never had a Local Enhanced Service for Incliseran. This applies to all ICB areas listed above.
