Your Request

- Any local guidelines or pathways used within your NHS ICB to inform clinicians on coeliac disease diagnosis and follow-up care. We are interested in guidance for adults and children seen in any setting.
- If your area does not have any local pathways for coeliac disease, please specify which clinical guidelines (e.g. NICE, ESGPHAN, BSG) are recommended to clinicians.

If it is not possible to provide the information requested due to the information exceeding the cost of compliance limits identified in Section 12, please provide advice and assistance, under the Section 16 obligations of the Act, as to how I can refine my request.
