**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 23 April 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

This FOI request relates to James Cook University Hospital (JCUH) Urgent Treatment Centre.

Could I ascertain if the tender process outlined how many patients the James Cook University Hospital Urgent Treatment Centre has been commissioned to see on a daily/weekly basis, and what happens if this figure is exceeded.

**Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

Within the tender documentation (Invitation to Tender (ITT) Document 12 – Activity Data) that was provided as part of this procurement and upon which the bids were made, urgent care activity, at the James Cook site, was forecasted at 62,911 per annum. This was estimated using latest available activity data and forecasting the anticipated flows of patients between services within the new service model.

If actual activity levels differ significantly from those forecasted then a contract led, activity review process would need to be undertaken, to understand the reasons for the differences and what mitigation can be taken.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website <https://northeastnorthcumbria.nhs.uk/>.
