

Area ICPs feedback

Previously agreed role for Area ICPs:

- Develop and strengthen relationships between professional, clinical, political and community leaders to share intelligence, identify common challenges and best practice as part of our 'Learning and Improvement System' in the North East and North Cumbria.
- Analyse the JSNAs from each of the Health & Wellbeing Boards in their Area to feed into the Integrated Care Strategy setting process
- Ensure the work of the Area ICP is focused on the priorities of local residents and service users to identify those issues that cut across its constituent places

Feedback from first two rounds of Area ICP meetings

- Still building a consensus on purpose and operating model
- Useful forum to identify strategic issues that cut across place
- Meeting frequency and inclusive membership model needs to be reviewed
- A stocktake of Area ICP arrangements would be welcomed
- This could feed into our Partnership Governance Self-Assessment (recommended by NHS England)



Opportunities for cross-place working: developing a Work and Health Strategy

- DHSC/DWP Joint Work and Health Unit invited the North of Tyne Combined and Local Authorities to explore the development of a work and health strategy with the ICB
- This would focus on how we better tackle the health barriers that many people face in accessing and sustaining good work
- External mapping support from IPPR North identified several key themes:
 - Seizing the opportunity of devolution to develop a shared programme of Public Service Reform to address inequalities in health and wellbeing outcomes
 - > Focusing on what works to inform the investment principles made by strategic partners
 - Co-designing a formal work and health system, connecting frontline primary care, voluntary sector and employment support services in our places
 - Creating more 'good work' in the local public and private sector, including through our network of anchor institutions to widen local employment pathways
 - Promote the principles of good work through initiatives such as the Better Health at Work Scheme and North of Tyne Combined Authority's Good Work Pledge
 - Explore Community Wealth Building approaches to develop local supply chains, improve employment conditions, and increase the socially productive use of wealth and assets
- We will test these themes over the summer with an update at our next ICP meetings

Adult Social Care (ASC) Providers Forum

- ASC providers are critical partners in planning, delivering, and improving care and outcomes
- DHSC Guidance requires each ICP to establish an ASC Providers Forum building up from existing place-based arrangements

North East ADASS colleagues have recommended

- A biannual ASC Providers Forum with representation from across places and sectors including national and local providers of nursing, residential, domiciliary, LD, and autism services
- Agendas to focus on areas of common concern, including service fragility, policy standardisation, workforce challenges, urgent care and discharge, and technological and digital innovation,
- Each LA would continue to convene their local Provider Forums and feed in cross-cutting themes
 from these to the regional ASC Forum, and then on to the Strategic ICP
