<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 8 November 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I note from an email from the Sunderland Voluntary Sector Alliance that: "Sunderland Voluntary Sector Alliance have been funded by the North East & North Cumbria Integrated Care Board to understand the provision of community assets across Sunderland, in order to identify opportunities for growth & capacity building within VCSE sector."

Under FOI, can you please provide me with the following:

- 1. How much NHS money has been awarded to Sunderland Voluntary Sector Alliance, both as part of Sunderland Council and as a CIO by the ICB?
- 2. Over what period of time it has been awarded?
- 3. A complete list of the purpose for which each Grants was awarded.
- 4. Whether these grants were restricted or unrestricted.
