Please find the information you requested on behalf of the ICB as follows;

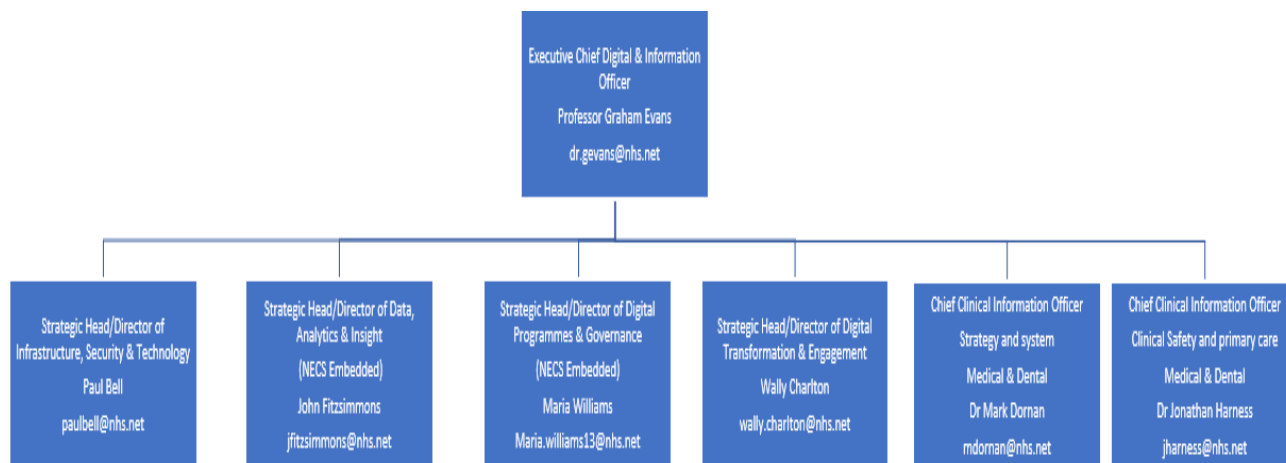
