<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 30 July 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

We have dealt with your request in accordance with your "right to know" under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information "held" by a public authority unless an appropriate exemption applies.

Your Request

- 1. How many children in Hebburn and Jarrow had the measles virus in 2023 and 2024?
- 2. How many children aged 5 to 11 live in Jarrow and Hebburn?
- 3. How many of that age group had measles?
- 4. How many children aged 12 to 16 had measles in Hebburn and Jarrow in 23 to 24?
- 5. How many children in the last 10 years in South Tyneside have had measles out of how many in population of children (percentages)?

Our Response

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. However, we have determined that the information is held by the Public Health Team at South Tyneside Council within the North East and North Cumbria region.
