**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 7 October 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

We have dealt with your request in accordance with your “right to know” under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information “held” by a public authority unless an appropriate exemption applies.

**Your Request**

Under the Freedom of Information Act I hereby request the following information, in electronic copy and to the extent possible in Excel:

- A list of the top 100 independent service providers (“ISP”) that the ICB has paid in relation to outsourcing NHS funded services in the following areas, ranked by amount of fees paid:
  - Ophthalmology
  - Gastroenterology (including Endoscopy/ Gastroscopy – if possible, shown separately)
  - Dermatology
  - ENT services
- Within that list, please include the following information:
  - Name of the ISP
  - Year first outsourced to this ISP
  - Fee paid to this ISP in FY2023/2024
  - Fee paid to this ISP in FY2022/2023
  - Fee paid to this ISP in FY2021/2022

- Fee paid to this ISP in FY2020/2021
- Please also share a general register or directory of companies that the ICB outsources to across all healthcare service verticals, including the applicable vertical for each company.

## **Our Response**

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. NENC ICB does not outsource these services.
