<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 30 April 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing to request the following information under the Freedom of Information Act 2000.

Please can you state the total ICB budget allocated for all local enhanced services (LESs) provided by GP practices in your area, for each of the following financial years:

- 2022/23
- 2023/24
- 2024/25

Please answer these questions for each of the ICBs you are responsible for.

If it is not possible to provide the information requested due to the information exceeding the cost of compliance limits identified in Section 12, please provide advice and assistance, under your Section 16 obligations, as to how I can refine my request to be included in the scope of the Act.

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, NENC ICB holds some of the information you have requested. However, ICB budgets for 2024/25 are exempt from disclosure because they are intended for future publication. It is considered it is reasonable to withhold the requested information prior to publication because ICB budgets for 2024/25 will once finalised and approved for publication by the NENC ICB Executive Board be published and made available on the ICB website by 31/05/2024.

We believe that following the established date of publication is sensible, in line with accepted practices, and fair to all concerned. It is acceptable to manage the availability of this information by planning and controlling its publication, as the timetable for publication enables internal consideration of the information prior to its public release.

When considering the application of this exemption we are required to assess the public interest in withholding or disclosing the requested information. There is evidently a public interest in ICB budgets for 2024/25, however this is best served by preventing the disclosure of that information ahead of the ICB's predetermined timescale. It is considered that the public interest is to enable the ICB to finalise, approve and publish this information in the near future. We would therefore argue the public interest is adequately served by the existing publication date, pursuant to the ICB's existing intentions.

Therefore, on this occasion, we consider the public interest in withholding the requested information outweighs the public interest in providing the requested data at this time.

2022/23: ICB budget from 1^{st} July 2022 – 31^{st} March 2023 = £32,216,939 **2023/24:** ICB budget from 1^{st} April 2023 – 31^{st} March 2024 = £43,261,162 **2024/25:** ICB budgets for 2024/25 have not yet been approved by the Executive Committee.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website https://northeastnorthcumbria.nhs.uk/.
