<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 8 April 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am looking for some information to be answered under the Freedom of Information Act relating to the Additional roles reimbursement scheme (ARRS) underspend for 2023/24 which Primary Care Networks (PCNs) are able to bid for as per the Network DES 2023/24 point 7.5.5.

My questions are as below:

- 1. What is the total ARRS allocation sum for the PCNs in your ICB?
- 2. How many PCNs are in your ICB?
- 3. How much ARRS underspend has the ICB recorded in its footprint?
- 4. Does the ICB intend to reallocate this money to PCNs? If not, why not?
- 5. How many bids did the ICB receive for this money?
- 6. On average, how much money did each bid ask for?
- 7. Can you share the bid documents with us in a way to account for the large file size?
- 8. How many of these bids were successful? As a number and a percentage.
- 9. How much money will be redistributed?
- 10. When will this money be redistributed?
- 11. If the money is not redistributed, what will it be used for?

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you requested.

- 1. Total ARRS budget for 2023/24 is £76,429k, of which £48,211k was directly received by the ICB, the remaining £28,218k held by NHS England until required.
- 2. In 2023/24 NENC had 67 PCNs.
- 3. NENC ICB has not yet received / processed all PCN claims for 2023/24 however, the forecast underspend is £6,976k, which is retained by NHS England.
- 4. In August 2023, (despite this still being detailed in the 2023/24 Network Contract DES) NHS England advised that this redistribution process would not be undertaken to ensure future sustainability of the scheme and PCNs. As per question 3 above, underspend is retained by NHS England.
