Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received on 9 October 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

Please see below a list of FOI questions:

- 1. Please list all organisations commissioned to provide rehabilitation services in your area and their contract values. To clarify, I would like the rehabilitation figures, then the neuro rehabilitation figures.
- 2. Please state the total budget for rehabilitation services in your organisation and the amount specifically allocated to neurological conditions.
- 3. Please provide the most recent data you hold on waiting times for neurological rehabilitation services, including community and inpatient settings.
- 4. Please provide details of any formal arrangements or structures in place for involving people with neurological conditions in the planning or delivery of rehabilitation services.
- 5. Do you have a neuro-rehab service pathway integrated with neurology service?
- 6. Does your organisation have a neuro clinical lead?
- 7. How do you ensure the needs of people with neurological conditions are addressed in your mental health provision from primary care to acute?
- 8. What specific training and support do you give staff providing mental health and Talking Therapies support to ensure they are equipped to work with people with neurological conditions? If you do not provide this support does another organisation?

- 9. Who currently in your organisation has leadership responsibility at board level for rehabilitation services? If so, what is their title and responsibility?
- 10. Who currently in your organisation has leadership responsibility at board level for neurology services? If so, what is their title and responsibility?

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

1. Organisations commissioned to provide rehabilitation services:

County Durham place:

County Durham and Darlington NHS Foundation Trust are commissioned by NENC ICB to deliver a range of non-neuro rehabilitation services. The contract values are part of the overall block contract with the Trust.

Newcastle Gateshead and Northumberland and North Tyneside places:

- The Newcastle upon Tyne Hospitals NHS Foundation Trust: Neuro Rehabilitation and Rehabilitation Services. The contract values are part of the overall block contract with the Trust.
- Gateshead Health NHS Foundation Trust: Adult Neuro Team based at the Queen Elizabeth Hospital. The team provide virtual, outpatient and community physiotherapy for patients with neurological diagnosis and issues. The contract values are part of the overall block contract with the Trust.
- Northumbria Healthcare NHS Foundation Trust: Adult Acquired Neurological Speech and Language Therapy (SALT). To provide an expert SALT service to meet communicative and swallowing needs arising from an acquired neurological condition for adults in the community in North Tyneside and in patients within North Tyneside General Hospital. The contract values are part of the overall block contract with the Trust.

North Cumbria place:

North Cumbria Integrated Care NHS Foundation Trust is commissioned to provide rehabilitation services. The contract values are part of the overall block contract with the Trust.

South Tyneside and Sunderland place:

South Tyneside and Sunderland NHS Foundation Trust provides neuro rehab, steps to health rehabilitation service which includes cardiology, respiratory, pulmonary rehab and chronic disease management. The contract values are part of the overall block contract with the Trust.

Tees Valley place:

- South Tees Hospitals NHS Foundation Trust provides Pulmonary, Neuro and Cardiac services. Contract values are part of the overall block contract with the Trust.
- North Tees and Hartlepool Hospitals NHS Foundation trust provides Heart Failure and Pulmonary services. Contract values are part of the overall block contract with the Trust.
- 2. NENC ICB does not break down budgets to show rehabilitation services, or specifically anything around neurological conditions. Much of the costs relating to rehabilitation services will be part of wider block funding with NHS Foundation Trusts and larger contracts with Local Authorities, for which the level of detail request is not available.

3. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. However, we have determined that the information is held by the acute hospital NHS foundation trusts (FTs) within the North East and North Cumbria region.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email addresses for those foundation trusts to make your request.

In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. However, we have determined that the information is held by the primary care providers within the North East and North Cumbria region.
