**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received on 2 December 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

**1. Commissioning Responsibility and Policy Alignment**

- a. Which organisation currently holds commissioning responsibility for LAAC (Left Atrial Appendage Closure) services in your region (e.g. regional specialised commissioning team, delegated ICBs, or NHS England national team)?
- b. Does your organisation currently follow the NHS England national commissioning policy for LAAC (2018, updated 2023), or has a local policy or adaptation been developed? If a local policy, pathway, or protocol exists, please provide a copy or link.
- c. If a local policy is under development or review, please confirm:
  - Expected date of publication or implementation.
  - Whether this is being coordinated with NHS England or local ICBs.
- d. Has any local clarification or interpretation been issued to providers since the 2023/24 delegation of specialised services?
  - For example, memoranda, board papers, or internal briefings regarding LAAC commissioning responsibilities.

#### Further Clarification

Further to my initial FOI submission, I realised I omitted some contextual information.

It is our understanding that NHS England has formally delegated 59 specialised services to ICBs and regions (NHS England Board Paper, 5 December 2024 – Annex A). This includes Adult Specialist Cardiac Services, specifically: 13T – Complex Interventional Cardiology, under which LAAC/LAAO sits.

NHS England's "Cascade Delegation: Commissioning Integration" guidance confirms that ICBs now hold responsibility for:

- commissioning,
- service oversight,
- activity and planning,
- and implementation of national policies for all delegated services.

#### **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

1. Commissioning Responsibility and Policy Alignment
  - a. NENC ICB currently holds commissioning responsibility for LAAC (Left Atrial Appendage Closure) services in the north east and north Cumbria region
  - b. Yes, the organisation follows the NHS England national commissioning policy for LAAC (2018, updated 2023).
  - c. There is no local policy under development.
  - d. There has been no local clarification or interpretation issued to providers since the 2023/24 delegation of specialised services.
2. Current Service Provision and Activity Levels
  - a. The NHS foundation trusts (FTs) delivering LAAC procedures within the NENC region are the Newcastle-upon-Tyne Hospitals NHS FT and South Tees Hospitals NHS FT.
  - b. No provider sites been rejected to deliver LAAC.
  - c. There are no new sites are going through approval for delivering LAAC.
  - d. No, the region has not set any activity targets, trajectories, or expectations for LAAC growth toward the 1,000-procedure national projection referenced in the NHS England commissioning policy? If yes, please provide details or supporting documentation.
3. Funding and Commissioning Approach
  - a. LAAC procedures currently commissioned on a block arrangement.
  - b. There have been no local amendments or clarifications to the national tariff or payment mechanism for LAAC.
4. Forward Planning for 2026/27
  - a. NENC ICB is not undertaking, or planning, a review of LAAC service commissioning.
  - b. LAAC has not been referenced in any ICB delivery plan, stroke prevention strategy, or specialised cardiac service plan for 2026/27.
  - c. There is no commissioning or clinical lead for LAAC or specialised cardiac services within NENC ICB.

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.
