# Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 14 February 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up - Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

#### **Your Request**

I am writing to request information pursuant to the provisions of the Freedom of Information Act. I kindly request acknowledgment of receipt of this email, and I anticipate a comprehensive response within the statutory timeframe of 20 working days, as mandated by the aforementioned legislation.

Specifically, I seek the following information:

- What is the main provider of adult community health services in each of the areas served by the ICB?
- What is the main provider of children's community health services in each of the areas served by the ICB?
- For each of the ICB's main adult community health service provider contracts, which month and year is it due to run out?
- For each of the ICB's main children's community health service provider contracts, which month and year is it due to run out?
- For each of the areas served by the ICB, do you have any current plans to procure or award a new contract for its adult or children's community health services?

## **Our Response**

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

#### County Durham place

- Main provider of adult community health services is County Durham and Darlington foundation Trust community contract.
- The main provider of Children's community health services is County Durham and Darlington NHS Foundation Trust Acute contract.
- Current contract ends 30 September 2028 (adult)
- Current contract ends 31 March 2024 (children)
- There are no current plans to procure or award a new contract.

#### Newcastle, Gateshead, North Tyneside, Northumberland and South Tyneside

- Providers of both adult and children's community health services are:
  - o Newcastle Newcastle upon Tyne Hospitals NHS FT
  - o Gateshead Gateshead Health NHS FT
  - o North Tyneside and Northumberland Northumbria Healthcare NHS FT
  - o South Tyneside South Tyneside and Sunderland NHS FT
- Current contract end dates are all March 2024

#### North Cumbria place

- Main provider of adult community health services is North Cumbria Integrated Care NHS Foundation Trust (FT)

## Hartlepool and Stockton / Redcar and Middlesbrough

As most of the community services are in the main FT contracts, a contract for these services will be awarded as part of the main FT contract award process, under the PSR Regulations.

There are a small number of community services that are delivered outside of the Trusts, contracts will be awarded in line with PSR regulations. A procurement for services is considered on a case-by-case basis for each service, rather than at a full community contract level.

#### Darlington:

The main community contract is not expiring. There are a small number of community services that are delivered outside of the Trust, contracts will be awarded in line with PSR regulations and procurements for these services are considered on a case-by-case basis.
