

 - b. If not, what is the current wait time for CAMHS triage and assessment for children placed in your area by an out of borough area?
 - c. Who is the provider for this service (inc contact details)?
- 3. What is the emotional health offer for children whilst they await a CAMHS assessment? Who is the provider for this service (inc contact details)?
- 4. What is the current wait time for neurodevelopmental assessments for children placed in your area by an out of borough area? Who is the provider for this service (inc contact details)?
- 5. Do you know of any barriers to accessing dental services for children looked after placed into your area?
- 6. Do you have any specialist services for children with obesity (i.e. complications of excess weight clinics)? Who is the provider for this service (inc contact details)?

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

Where we have made reference to NENC ICB region acute and mental health trust providers in the ICB place responses below, we have provided contact information for those providers towards the end of this letter.

County Durham place

- 1. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested for County Durham ICB place. However, we have determined that the information is held by County Durham and Darlington NHS Foundation Trust (CDDFT).
- 2. Please refer to the response to guestion 1.
- 3. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested for County Durham ICB place. However, we have determined that the information is held by Tees, Esk and Wear Valley NHS Foundation Trust (TEWV).
- 4. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested for County Durham ICB place. However, we have determined that the information is held by Public Health (County Durham), within Durham County Council.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email address for Durham County Council – foi@durham.gov.uk – to allow you to make your request.

- 7. Yes, there are specialist services for children with obesity within the NENC ICB region. These are provided by CDDFT in County Durham ICB place.

Newcastle Gateshead place

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested for Newcastle Gateshead ICB place. However, we have determined that the physical health service information is held by the Newcastle upon Tyne Hospitals NHS FT and Gateshead Health NHS FT, while all mental health services will be delivered by Cumbria, Northumberland, Tyne and Wear NHS FT.

North Cumbria place

1. Children/young people will usually receive an appointment within 3-4 weeks of receiving a referral.

- 2. Wait times for review health assessments are 8 weeks from receiving a referral in East Cumbria and 4 weeks from receiving a referral in West and South Cumbria.
- 3. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. However, we have determined that the information is held by Cumbria, Northumberland, Tyne and Wear NHS FT.

North Tyneside and Northumberland place

- 1. In North Tyneside and Northumberland ICB place, this service is provided by the children looked after nursing team at Northumbria Healthcare Foundation Trust (NHCFT) who's function sits within the child health business unit. The nursing team work across Northumberland and North Tyneside. NHCFT hold the data on waiting times the only data they share with the ICB safeguarding children's team is how many IHAs and RHAs have been completed in timescale.
- 2. Please refer to the response to question 1.
- 3. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested for North Tyneside and Northumberland ICB place. However, we have determined that the information is held by NHCFT and Cumbria Northumberland Tyne and Wear NHS Trust.
- 4. Across both Northumberland and North Tyneside there is a graduated response offer provided by a range of organisations including Local Authority, NNHCFT, Harrogate and District Foundation Trust and the Voluntary Sector. This is attached.
- 5. NENC ICB is not aware of any barriers to accessing dental services for children looked after placed into the Northumberland and North Tyneside area.

- 7. There is a Complications from Excess Weight (CEWs) pilot being delivered at the Great Northern Children's Hospital in Newcastle, referrals can be made to this pilot from Northumberland and North Tyneside.

South Tyneside and Sunderland place

- 1. In South Tyneside and Sunderland ICB place, there are no waits once a referral has been received. The provider is South Tyneside and Sunderland NHS Foundation Trust (STSFT).
- 2. There are no waits once a referral has been received. The provider is STSFT.
- 3. There is no dedicated CLA-specific CAMHS pathway, for CYP need CAMHS level services. All referrals are triaged by clinical need via the locality CYP mental health route. Where specialist Getting More Help / Risk Support there is a dedicated pathway through CNTW. The Getting Help commissioned provider is STSFT for South Tyneside and STSFT and Sunderland Counselling Service in Sunderland.
- 4. Children placed in Sunderland or South Tyneside by other local authorities have access to the same needs led Getting Help emotional wellbeing support as local residents. These services are not CLA-specific and are determined by clinical presentation or emotional need. Components of the Getting Help offer are:

- STSFT Getting Help function brief, early-help support including guided self-help, brief counselling or CBT-informed work, psychoeducation, and liaison with schools/carers.
 - Typical contact: within 10 working days
 - o First appointment: within 4 weeks for routine need
 - Urgent safeguarding triaged within 48 hours
- Kooth (digital) moderated online counselling and peer support platform for children and young people.
 - Self-referral
 - o 24/7 access to forums and resources
 - Scheduled sessions within service SLAs
- MHST (Mental Health Support Teams) school-based early intervention service providing brief interventions for mild-to-moderate presentations, group sessions, and consultation with school staff.
 - Referrals via education settings
 - o Warm handovers with Getting Help where needed
- Family Hubs (Sunderland & South Tyneside) provide family and parenting support and signposting into emotional wellbeing services (0–19 / 0–25 SEND).
 - o First point of contact for families and carers, not CLA-specific
- Sunderland Counselling Service commissioned to provide accessible counselling for young people aged 10 and above who require structured talking therapy.
 - o Referrals through GP, school, or self-referral depending on pathway.
- Autism Hub South Tyneside a community-based, needs-led early-support offer for children, young people, and families with neurodevelopmental needs, providing advice, drop-ins, and emotional regulation support prior to or alongside diagnostic assessment.
 - o Operated by STSFT in partnership with local VCSE organisations.
- Daisy Chain Sunderland a voluntary sector provider offering autism-specific emotional wellbeing, peer support, and early intervention for children, young people, and families, accessible through self-referral or professional referral.
 - Works in partnership with primary care, schools, and the Getting Help function to reduce distress and family breakdown risk.
- 5. The current median wait is 90 days.

- 7. There is one weight management dietitian in South Tyneside and Sunderland. The provider is STSFT.

Tees Valley place

- 1. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested for Tees Valley ICB place. However, we have determined that the information is held by community paediatric teams within acute hospital trusts in the Tees Valley area. These hospitals are South Tees Hospitals NHS FT, North Tees Hospital and Hartlepool NHS FT and County Durham and Darlington NHS FT.
- 2. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested for Tees Valley ICB place. The service is provided by Harrogate and District NHS Foundation Trust's Children in Care Service. In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual

requesting information, the FOI web portal for Harrogate and District NHS FT is Make a FOI request – Harrogate and District NHS FT

- 3. There is no CLA specific CAMHS pathway for children placed by an out of borough area.
- 4. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. The ICB wide response to question 6 is:

Access to routine dental care remains challenging and the ICB is exploring all options to improve the situation whilst we await national dental reforms. We are taking every opportunity to increase the units of dental activity that are commissioned and to improve access to urgent dental care. We have a local incentivised access scheme where practices have offered up appointments with the expectation that they prioritise patients in greatest clinical need and urgency. We have included looked after children as one of the priority groups within this scheme – details of the practices participating in this scheme are available on the ICB's website: NHS dentistry | North East and North Cumbria NHS.
