Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 5 December 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Could I please make a Freedom of Information request for information that I believe should have been arrived at during the creation of the ICB infrastructure strategy. While these may have not yet been published in some cases, or remain in draft form, I believe it is firmly in the public interest for this data to be collected as soon as possible and in whatever form available. Can I please request:

- 1. The total estimated backlog across the ICS area.
- 2. The total estimated backlog for primary care estates across the ICS area.
- 3. The total number of primary care premises
- 4. The total percentage of 'core, flex and tail' estate across the ICS area.
- 5. The total percentage of 'core, flex and tail' estate specifically for primary care estate across the ICS area.

Please state if this information is final or draft.
