## **Your Request**


My request relates to data held on continuing healthcare funding matters. Kindly provide data for 2021, 2022, and 2023.

- 2. Please confirm how many awards to provide continuing healthcare funding were made following decision support tool assessments in 2021, 2022 and 2023.
- 3. Please confirm how many cases requested local ICB appeals (Local Review Meetings / local appeal) of the negative decision of the decision support tool assessment for continuing healthcare in 2021, 2022 and 2023.
- 4. How many individuals were successfully awarded continuing healthcare funding following an local ICB appeals (Local Review Meetings / local appeal) in 2021, 2022, 2023
