Freedom of Information Act 2000 - Request for Information - NHS North East and North Cumbria Integrated Care Board (NENC ICB)

Thank you for your request received by North of England Commissioning Support (NECS) on 31 December 2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up - Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

Please provide me with the following information for the financial years 2020/21, 2021/22, 2022/23.

All expenditure made by your organisation, in every facet of its operations and purview, on translation, interpretation, and language services.

Please provide the aggregated total spent by your organisation and then, if possible, please provide this broken down by particular function for which the service was carried out.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

Primary Care Interpretation Services Spend

This covers North East and North Cumbria ICB, the ICB have only held the Primary care Interpretation services contract since April 2023, prior to the ICB holding it, it was with NHS England North East & Yorkshire region and the ICB do not hold the information for the period before the 1st April 2023.

The North East and North Cumbria Integrated Care Board (NENC ICB) does not hold all the records which you have sought. However, we have determined the records are held by NHS England.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email address for NHS England for you to make your request england.contactus@nhs.net (please write "Freedom of Information" in the subject line).

Other Programme Spend

The ICB and former CCGs also have interpreting spend in Other Programme as follows (broken down by financial year):
